- I. <u>Convening of the Meeting Ellen Thomas, President</u>
 The meeting started at 11:31 AM

- ٧. President Bloom's presentation and discussion (President Bloom, 30 min) President Bloom: A modest increase in state funding (head count driven) is expected. To get OBA money, NJIT must agree on two things: First, for students who have a household income at or below \$65,000 and no other support, all costs will need to be covered by NJIT. This could cost NJIT about \$3.5 million. Second, there would be a 4 year cohort rate for tuition and fees. This means that all costs would be at a fixed rate from freshmen to senior year. The state must also be held accountable on their end. A. Rosato: Does the cohort funding also apply to transfer students? Pres. Bloom: Yes. Pres. Bloom: We will never admit students to simply make more money, but it is time to graduate the students that are admitted. We need to improve our 67% graduation rate. It's time to have a conversation on how to do a better job for the students. Y. Perl: Andrew Christ said we are not going to build dorms with company that requires a certain guarantee of student occupancy. Pres. Bloom: The company is to be hired based on the fall 2022 dorm demand. The third party will pay the bill, while NJIT will own the land. A. Rosato: Are there any plans to have the new dorms allocate spacing for visitors and faculty? Pres. Bloom: No, but other dorms will allocate space for graduate students and faculty. D. Bunker: Will the third party guarantee the number of beds to NJIT or directly to the students? Pres. Bloom: No, just to NJIT, not to individual students. Y. Perl: How can we project how many people will actually come to NJIT? Pres. Bloom: Andrew Christ conduct a study examining cohort retention rate that determines future projections. D. Sollohub: The US Census project sees a decline in college attending students. How is NJIT dealing with this? Pres. Bloom: Although there is a decline, the applicant pool from last year was approximately 9200 for 1400 freshmen seats. NJIT is increasingly becoming known as a prominent research center. NJIT offers more focused niche activities and its reputation continues to improve. Question of how faculty and students can engage even more. R. Sodhi: Is there an expected graduate impact? Pres. Bloom: Yes, there has been a decline in graduation rates. After the President was done, Provost Deek continued the conversation. Provost Deek: We have the lowest Peer score amongst our peers (25%), which measures how NJIT is perceived by others. NJIT has done well, can do even better. Graduation rates and support to help students succeed have improved. P. Armenante: Although financial aid is given to students, many undergraduate students work, which is reflected in their academic performance. Is there already something in place that students will have to pledge to not work if they get financial aid? Provost Deek: We

don't have a system like that in place, and probably can't have something like that. A. Rosato: There are rigid boundaries between departments about chairing Ph.D. committees. Can they be taken down? Provost Deek: I endorse it. However, it is in the faculty and chair's hands, but lowering boundaries can be done. We are working on developing a IT strategic plan for Computer Science. We invite people to create a committee. Y. Perl: How is the relationship between NJIT and NJII? F. Deek: I will explain this at an upcoming Faculty Senate meeting to present and explain.

 Pres. Thomas gave a report at the IFM about the meeting with the BOT
 Executive Committee. Afterwards, President Bloom stated he will not seek, nor
 accept, to extend his contract beyond 2022. The BOT is working on a leadership
 profile. The Faculty Senate can put their own ideas on paper and then present
 them to the BOT. G. Thomas: A new president will have to support evaluation of
 the president. A. Rosato: Collect ideas from Faculty Senate members through
 email about this, and not wait for the BOT.

Evaluation of upper administrators: Current handbook 7.2 Evaluation of Provost, Vice Presidents, Deans and Chairpersons With the knowledge and cooperation of the President, the Faculty Senate will conduct periodic evaluations (at least every three years) by the faculty of the Provost, Vice Presidents, Deans, and Department Chairpersons. The Faculty Senate, after consultation with the President, may also evaluate the performance of other administrative officers whose work impacts academic affairs. The President of the Faculty Senate is responsible for transmitting the results of these evaluations to the President in the case of the Provost, and to the Provost for all others administrative evaluations. Pres. Thomas: G. Thomas (Chair of CFRR). An evaluation of upper administrators that has stronger language than that in the Handbook will not be accepted. In the Handbook there is no evaluation procedure for the President. G. Thomas: It should be possible to evaluate presidential priorities. Y. Perl: This might be the time to pass something stronger because it will affect the next president. A. Rosato: President Bloom will still be on retainer so it might not work because of his influence. Pres. Thomas: We can continue to work on

something stronger. G. Thomas: We should consider a list of things to go into the survey to evaluate the president.

Then there was a motion to send it back to committee (CGE). Motion to approve: D. Bunker. Seconded: D. Blackmore. 18 yes, 1 no, 0 abstentions. S. Ziavras will come back to a future Faculty Senate meeting with a revised proposal.
