Update from Elections Committee – Tiffany Small

There are 16 vacancies across the different constituency groups for voting members of the University Senate in 2017-2018. Elections are expected to be completed by May for all except for the Student Senate and the GSA, which will hold their elections in September.

University Senate President's Report

- 1) Library hours have been extended for the Spring 2017 semester, in great part due to student feedback.
- 2) All Web-Ex interviews have been completed for the University Librarian search, with campus interviews expected after the spring break. Recommendations to the Provost are expected by mid-April.
- 3) CoAD dean position has been posted and applicants are being reviewed by the committee.
- 4) Shared Governance survey results were shared.

Overall findings:

- Campus stakeholders are particularly satisfied with collegiality on campus.
- There are some concerns about the availability of resources, particularly for professional development.
- The lower level of satisfaction expressed by adjuncts and staff suggest there is room for improvement in the incorporation of these groups into shared governance.
