

# CAMPUS ADVISORS

## What is a Campus Advisor?

A Campus Advisor is a member of the NJIT community who can help the student navigate the conduct system. They serve as a resource to students and provide objective advice, feedback & support. They DO NOT represent students in the process.

## What does a Campus Advisor do?

Campus Advisors play a crucial role in helping participants understand the conduct process. They provide essential support to students who are going through the process and assist complainants and accused students in preparing for conduct meetings and hearings. Additionally, they accompany both complainants and charged students to conduct meetings and hearings and can review materials and provide fair and objective feedback.

## Am I required to have a Campus Advisor?

No. Students are not required to have a Campus Advisor. A Campus Advisor can be consulted if a student needs assistance navigating the process.

## Can I choose my own Campus Advisor?

Yes. Students can select an advisor from our list or ask another person of their choosing.

## Can my Campus Advisor accompany me to meetings or hearings?

Yes. Your Campus Advisor can attend meetings and hearings with you. We ask that you inform the Dean of Students Office of this in advance of the scheduled meeting.

## Does a Campus Advisor speak on my behalf in meetings?

No. Campus Advisors assist students by providing feedback and support as they navigate the student conduct or academic integrity process but DO NOT represent or speak on behalf of students in meetings and hearings.

## What information do I give to my Campus Advisor?

It is the student's responsibility to provide Campus Advisors with case information including any letters or documents sent by the Dean of Students Office.

## CAMPUS ADVISOR LIST

To request the assistance of a trained Campus Advisor, choose one name from the list below and email that Advisor to inquire if they are available. If that Campus Advisor is unavailable, you may contact another name on the list. Students are not required to have a Campus Advisor. Students may also have an advisor that is outside this list. Students are responsible for sharing case information with their Campus Advisor and providing the Conduct Officer handling their case with the name of their Campus Advisor before any meetings/hearings.
