#### Executive Summary:

On 2/9/2021 and 2/10/2021, Omega Environmental Services conducted representative ATP surface testing and SARS-CoV-2 environmental sampling in the following buildings on the NJIT campus:

- Tiernan Hall
- Kupfrian Hall
- Campus Center
- Weston Hall
- Mechanical Engineering Center (MEC)
- Guttenberg Information Technologies Center (GITC)
- Cullimore Hall
- Central King Building (CKB)

- Faculty Memorial Hall (FMH)
- Life Sciences & Engineering Center (LSEC)
- Cypress Residence Hall
- Wellness Entertainment Center (WEC)
- Greek House Delta Phi Epsilon
- Greek House Alpha Sigma Phi
- Redwood Residence Hall
- Honors College Residence Hall

The purpose of this testing was to document adequate disinfection and cleaning by the NJIT Building Service staff.

Parameter	Results
Adenosine Triphosphate (ATP) Direct Reads: Bioluminescence Meter (Detects Bacteria and Bio- Load)	<ul> <li>55-out-of-265 representative ATP surface samples collected reported elevated ATP levels (20.7% of samples). 11-out-of the 55 samples with elevated ATP levels were pre-cleaning samples meaning they were collected before the area was cleaned by NJIT cleaning services.</li> <li>Omega Environmental Services collected SARS-CoV-2 surface samples on all representative surfaces with elevated ATP levels, that were not recleaned by NJIT Building Services.</li> <li>In the Wellness Entertainment Center, the average precleaning ATP concentration with 150.5 RLU, with 20% of the samples indicating elevated ATP levels. The average post-cleaning ATP concentration with 56.5 RLU, with a 62% decrease in ATP concentrations.</li> </ul>
Coronavirus-19 PCR Samples	• Laboratory results indicate all the SARS-CoV-2 samples collected on 2/9/21 and 2/10/21 were negative.

#### Bio-Load and COVID-19 Field Sampling & Analysis Protocol:

While a COVID-19 PCR DNA sequencing field testing method has become available, pre-screen methods that apply to overall bacteria cleaning are being employed to more efficiently clear areas and reduce testing costs.

- REAL-TIME FIELD SCREEN USING ATP DIRECT-READ BIO-LUMINESCENCE METER AND WHITE CLOTH TESTS: Omega field IH to inspect the room and collect ATP swabs on all component basis to assess overall cleaning thoroughness. If there are ATP swab results statistically above "typical background," re-cleaning of the room will be requested followed by repeat ATP testing before proceeding with further testing.
- COVID-19 PCR DNA SEQUENCING METHOD: Once a room passes the above described bio-load testing protocols, a COVID-19 PCR swab will be collected from alternating room locations.
- COVID-19 PCR AIR SAMPLING METHOD: Air samples are collected using a linear oscillating pump in conjunction with a 0.3 µm Polytetrafluoroethylene (PTFE) filter housed 37 mm cassettes. The pump pulls the air from the surrounding area into the cassette where any airborne virus particulates are captured. The samples are collected at a flow rate of 15 liters per minute (LPM), for 2 hours, totaling 1800 liters. Once sampling is complete, samples are shipped to an independent laboratory for analysis. Samples are analyzed via a polymerase chain reaction (PCR) method. The PCR method relies on a protein responsible for DNA replication in cells, please note this protein will only replicate DNA strands that match the COVID-19 sequence. If replication exceeds a threshold established by the laboratory the sample is determined to be positive for the COVID-19 strand. Test results should be used as metrics for cleaning success rather than a direct estimator for infection potential.

- Omega Environmental Services collected SARS-CoV-2 surface samples on all representative surfaces with elevated ATP levels, that were not recleaned by NJIT Building Services.

ND = not detected, no genetic marker is detected within 40 PCR cycles. NA = not applicable. The detection limit is 10 copies/reaction.
