

FINANCIAL STATEMENT 2025-2026

All international students who wish to receive an I-20 or DS-2019 form must submit documents that prove they have sufficient funding available to them to cover all estimated educational and living expenses.

Please read before you submit this form.

- 1) Evidence of financial capability should be official, showing sufficient funds to cover the educational and living expenses for one year of study. Costs include, but are not limited to, tuition and fees, room and board, health insurance, books and personal expenses.
- 2) Acceptable forms of evidence include: official bank statement, letter from a bank or letter of scholarship. Documents cannot be more than 6 months old and must be in English. If your proof of funding is not in U.S. dollars, please include a print out from the currency converter at <https://www.oanda.com/currency-converter>.
- 3) The financial sponsor must complete and sign the bottom portion of this form in ink or using a digital signature. If more than one sponsor is needed to cover the total funding amount, each sponsor must complete a separate form. Bank statements must include full name of account holder and type of account.
- 4) If you have a spouse and/or child(ren) who will live with you in the U.S. as your F-2/J-2 dependents, add **\$6,000 for your spouse** and **\$4,000 for each child** to the total proof of funding you are required to submit.
